### **Q3: LONG DESCRIPTION OF THE CASE STORY**

The overall objective of the VUE is to optimize and integrate processes of foreign trade. The specific objectives are: to) significantly reduce the time and costs of transaction in the realization of foreign trade activities; (b) facilitate the processing of authorizations and certifications in a single point of access via the Internet; (c) provide operators of foreign trade information on applicable requirements and procedures in progress status; (d) the immediate availability of records between the public institutions involved and the reduction of the probability of different information between registers; (e) encourage cooperation between public institutions involved; (f) make available for public institutions sufficient information to carry out a control in an optimal way.

Stage of BPR/ISP:

In this stage is made an analysis of the environment, of the current situation, a future model defines and establishes a plan of action in each of the entities that make up the VUE.

At the stage of analysis and design, requirements are defined to enable the implementation of the system, reflecting the particular needs of the users; and every need is assigned to the components of the system, structurally designing an interface between components.

Stage of development and testing:

Customer requirements are developed on real and put on evidence codes. In this stage of the project, there are changes requested by the entity or a misinterpretation by the developer.

Connection phase (implementation and maintenance):

This stage was carried out by parties, first the entities that did not have a system and then with the entities that had a system that was connected with the VUE. It was a long stage, since institutions did not meet the times of internal development of their systems.

It made an investment of \$15,824,189
