

The *Interrelations between Public Policies, Migration and Development (IPPMD) in Cambodia* is the result of a project co-financed by the EU Thematic Programme on Migration and Asylum and carried out by the OECD Development Centre in ten partner countries: Armenia, Burkina Faso, Cambodia, Costa Rica, Côte d'Ivoire, the Dominican Republic, Georgia, Haiti, Morocco and the Philippines.

The project in Cambodia aims to provide policy makers with empirical evidence on the way migration influences specific policy sectors – the labour market, agriculture, education, investment and financial services – and, in turn, how sectoral policies affect migration. The report on Cambodia addresses three dimensions of the migration cycle: emigration, remittances and return.

The IPPMD project in Cambodia was carried out in close collaboration with the Ministry of Interior and the CDRI. It provides **empirical evidence** on the interrelations between public policies and migration based on **quantitative and qualitative fieldwork**.

This event will serve as a platform for a dialogue between policy makers and representatives from academia, civil society and international organisations. The launch specifically aims to:

- Share and discuss the findings and policy recommendations of the IPPMD project with a
 focus on Cambodia, but in a comparative perspective. This will highlight what lessons other
 countries can gain from the Cambodian experience and what Cambodia can learn from other
 countries;
- Explore how the findings and recommendations of the research project can be translated into concrete action plans that integrate migration into key sectoral policies in Cambodia and its national development strategies.
