Arrival of new DCD Director

Mr. Jorge Moreira da Silva was appointed Director of the OECD's Development Co-operation Directorate effective from 1 November 2016. Prior to joining the OECD, he was Portugal's Minister of Environment, Energy and Spatial Planning (2013-15), Member of the Portuguese Parliament and Chairman of NATO Parliamentary Delegation (2015-16). He has a long professional career supporting climate change issues, including at UNDP, in academia and think tanks, and within Portuguese and EU administrations.

As Director, he will collaborate closely with the DAC and other entities of the OECD's Development Cluster to strengthen the Organisation's contribution to the international governance architecture and the 2030 Agenda for Sustainable Development.

2nd High-Level Meeting of the Global Partnership: towards inclusive and accelerated implementation of the 2030 Agenda

The Second High-Level Meeting of the [Global Partnership for Effective Development Co-operation](#) on 30 November – 1 December 2016 in Nairobi, Kenya attracted over 4,500 participants from 150 countries – governments, parliaments, civil society, business, philanthropy, academia and others. Hosted by President Kenyatta, the vibrant multi-stakeholder meeting demonstrated renewed engagement and leadership. The Nairobi Outcome Document articulates differentiated commitments to effective development co-operation and highlights leaving no one behind as a cross-cutting challenge.

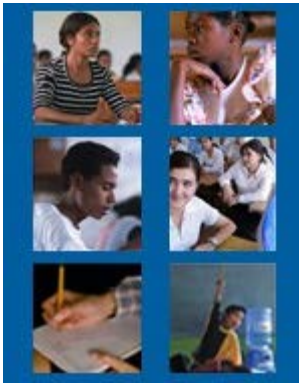


New OECD guidance aims to reduce corruption in aid sector

New international guidance on fighting corruption in the development sector calls on countries to create or improve systems for avoiding and responding to corrupt practices in the management and delivery of aid by development agencies and private firms. These systems should include codes of ethics, whistleblowing mechanisms, financial controls and sanctions for misconduct, among other elements.

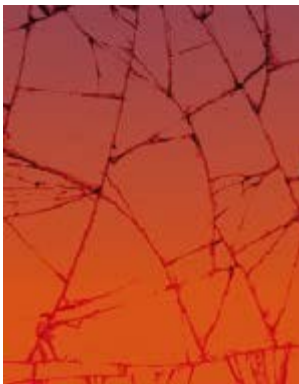

States of Fragility 2016 launched in Nairobi

States of Fragility 2016: Understanding Violence was launched on 30 November at the [2nd High-Level Meeting of the GPEDC](#) in Nairobi Kenya, by a panel including Minister Joe McHugh of Ireland and Vice Minister María del Carmen Nasser de Ramos of Honduras. The report is centred around the OECD's fragility framework, a multidimensional model that identifies 56 contexts as fragile in 2016, with 29 (over half) of those being middle income countries (MICS). Fragile contexts received 64% of ODA between 2011-2014, and are, on average, more aid-dependant than other developing countries: how ODA is spent there matters. The report also places a spotlight on violence in the world, as a contributing factor to fragility, with recommendations on preventing and reducing its impacts.

This new joint OECD-World Bank report highlights the new and increasing developmental challenges that Small Island Developing States (SIDS) face due to natural disasters and climate change. It unpacks the scope and nature of concessional finance directed to SIDS to build resilience to climate change and natural disasters, and offers targeted recommendations to enhance the scope and quality of this financing.

2016 Progress Report: Making Development Co-operation More Effective

The 2016 edition of the report assesses the degree of implementation of several international commitments for effective development co-operation, analysing the causes for progress and mapping existing bottlenecks. It is based on original data collected by governments in 81 low and middle-income countries, assessing the performance of close to 90% of development co-operation



programmes for these countries, and reflecting the behaviour of 125 countries and organisations that provide development co-operation.

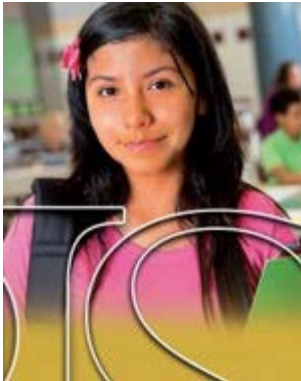
Aid For Trade and the Sustainable Development Agenda: Strengthening Synergies
