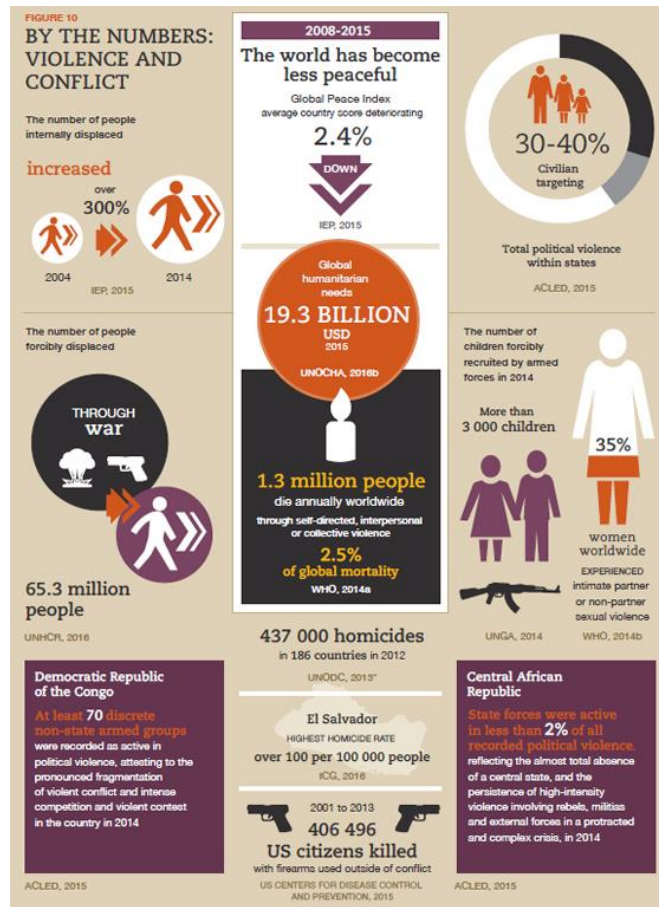


Dispelling the myths of triangular co-operation
