The discussion will enable members of the UN Inter-Agency Task Force on Financing for Development to provide targeted feedback on the recently launched "Compendium" describing the proposed aims, scope, and emerging features and statistical parameters of the TOSSD measurement framework. Representatives from the OECD and UN-DESA Secretariats will lead the exchange and elaborate on questions and issues selected by IATF members. The outcomes will be documented and integrated into subsequent iterations of the TOSSD compendium that will be developed over the course of 2016 through successive global consultation processes. They will also be an input to the Task Force's 2017 report and online annex. The final version of the "TOSSD Compendium" will be submitted for international endorsement.

Please select 1-2 priority questions or areas from the TOSSD compendium for discussion:

Background: Motivations and aims of TOSSD

- 1. Are the objectives of the TOSSD measurement framework clear? What elements of the stated TOSSD objectives could be sharpened?
- 2. Is the distinction between ODA and TOSSD sufficiently clear? If not, how could this be clarified further?
- 3. How could TOSSD capture results and/or investment quality considerations (e.g. jobs created, technology improvements, energy cost reductions, etc.)?
- 4. What international standards and principles should be integrated and monitored in the TOSSD framework?

Supporting the 2030 Agenda and AAAA

- 5. Can it be assumed that all activities with a developmental purpose currently eligible as ODA also qualify as
- 6. Can activities motivated by the provider's self-interest be included if they have an equally important developmental purpose or are expected to have a developmental impact? How could boundaries for mutually beneficial activities in TOSSD be defined?
- 7. How, and to what extent, could trade finance be covered in TOSSD? What parameters could be used to determine the boundaries for TOSSD-eligible trade finance, where the motivations are both promoting domestic interests and developmental impact abroad?

Core Structure: Provider and Recipient Perspectives

8. Do the features of the TOSSD provider and recipient perspectives seem balanced, relevant and useful? What is missing?

Determining TOSSD-eligibility (providers, recipients, and activities)

- 9. What additional criteria for the decision tree could help further define the boundaries of TOSSD-eligible activities at country level?
- 10. What further insights and proposals could be considered for defining the TOSSD-eligibility of activities addressing development enablers and global challenges at regional and global level in the areas of climate change, migration, peace and security, and human rights?
- 11. Which alternative multi-dimensional approaches beyond income criteria could be used to assess TOSSD recipient country eligibility?
- 12. Which multilateral organisations should be TOSSD-eligible and how can they be identified? Should these organisations include regional, sub-regional and sector-specific bodies?

Capturing private finance mobilised by official intervention

- 13. When measuring mobilisation in TOSSD from the provider perspective, should the resources mobilised be included in the measure or presented separately?
- 14. How could the recipient perspective measure adequately record private finance mobilised through TOSSD operations? What would be needed to ensure availability of detailed project information so that TOSSD could capture the totality of cross-border flows, including complex project schemes, at country level?
- 15. Which indicator best represents countries' ownership? Is there a need to reflect both paid-in and callable capital in the indicator?
