- How issues of child labour at mine sites should be addressed?
- What does "supporting the implementation of EITI principles" mean for upstream companies?
- Which due diligence recommendations can companies carry out individually, and which recommendations can be met through industry scheme or other collaborative initiatives?
- To what extent can iTSCi be relied upon by members to carry out due diligence, focusing specifically on (i) establishing chain of custody and/or traceability systems; and (ii) carrying out on-the-ground risk assessment and management, with particular regard to circumstances unique to the member's supply chain?
- How could existing mineral stocks be disposed?

- How can OECD and UN GoE due diligence training and ICGLR certification training be carried out to maximize implementation of due diligence and ICGLR certification as soon as possible?

- How can due diligence progress be demonstrated and measured? Can the ICGLR-OECD-UN GoE forum on implementation of the OECD and UN GoE due diligence recommendations assist with the development of indicators for assessing progress and any other implementing tools?
