## Special Focus: International Dialogue on "Exploring a New Global Partnership for the Least Developed Countries (LDCs) in the Context of the UN LCD IV"

> 24-26 November, Dhaka (Bangladesh)

As part of its activism to promote and advance the interests and concerns of Least Developed Countries (LDCs) in the Fourth United Nations Conference on the Least Developed Countries (UNLDC IV), the **Centre for Policy Dialogue (CPD), Bangladesh** in association with the **OECD Development Centre, Paris** organized an International Dialogue on "Exploring a New Global Partnership for the Least Developed Countries (LDCs) in the Context of UNLDC IV".

The partners of the dialogue were the United Nations Development Programme (UNDP), Dhaka, the Commonwealth Secretariat, United Kingdom and the International Centre for Trade and Sustainable Development (ICTSD), Switzerland.

Within the context of the Fourth United Nations Conference on LDCs (UN LDC IV), taking place in Istanbul, Turkey on 30 May - 3 June 2011, the objective of this event was to generate recommendations towards a framework for a new international agreement in support of the LDCs. The dialogue was attended by high level policy makers, leaders of civil society organizations and think tanks, development organizations, non-governmental organizations, apex bodies, private sector, academics, experts, and stakeholders globally.

It concentrated on five areas in particular: (i) Enhancing Trade, (ii) Promoting Investment, (iii) Access to Technology, (iv) ODA for Productive Capacity Development, and (v) Domestic Institutional and Policy Reforms.

## **OECD Green Growth Strategy Workshop**

## > 10-11 February 2011, Paris

To ensure that green growth policy recommendations are relevant to countries' needs, the OECD organised a consultation to review the first draft of the Synthesis Report on 10-11 February 2011. The workshop brought together policymakers and experts across OECD and partner countries, as well as a range of stakeholders from international organisations, business, and civil society. The purpose of the workshop was to review OECD's latest work on the Strategy's Synthesis Report and to seek feedback to ensure that it is a genuinely useful tool to support countries' transition to

greener economies.

The <u>Green Growth Strategy</u> will be a way to manage pressing challenges to economic development and resilient ecosystems. It will lay out the tools needed to shift to a more sustainable growth path, while identifying the benefits and economic opportunities that come from heading in that direction. A first step of this work will be the Synthesis Report, which will be submitted to Ministers at the OECD Ministerial Council Meeting in May 2011. IRMA Website

## **Development Symposium during the UN LDC IV**

## > 10-11 May 2011, Istanbul

In conjunction with the Fourth United Nations Conference on the LDC (UNLDC IV) on 9-13 May 2011 in Istanbul, we propose a two day Development Symposium. Through a series of events organized by the civil society, private sector, international organizations and other relevant LDCs stakeholders, the Symposium will constitute a space where policy makers, IGOs, NGOs, academics, policy researchers and analysts, and private actors will meet to generate innovative thinking, analysis and dialogues on pressing issues in the sustainable development policy domain of LDCs. The main goal is to provide targeted inputs on the role of two key factors in particular: (i) emerging partners for development and (ii) trade, in fostering structural transformation in LDCs, to inform the UNLDC IV negotiating process.

The Symposium will be organized by a consortium of organizations that will be responsible for holding individual sessions.

The Opening High Level Plenary will be organized by the Development Centre and Centre for Policy Dialogue, in collaboration with the International Centre for Trade and Sustainable Development, Commonwealth Secretariat and our local partner TESEV.

## Consolidate policy advances to create a Latin American decade

## > 26-Jan-2011

The uneven global recovery is challenging Latin America and the Caribbean, but the region will emerge stronger from the crisis with high growth potential if it continues deepening integration into the global economy. This was one of the main conclusions reached by leaders and experts participating in the III International Economic Forum Latin America & the Caribbean 2011, organized for the third consecutive year by the OECD Development Centre, the Inter-American Development Bank (IDB) and France's Ministry of Economy, Finance and Industry.

## Are working remittances relevant for credit rating agencies?

## > 04-Jan-2011

This paper by Development Centre economists Rolando Avendaño and Sebastián Nieto-Parra have studies the impact of workers' remittances on sovereign ratings in 55 developing countries over the period 1993–2006. The paper has been included in the first issue of new journal Review of Development Finance. Results suggest that there is no single model to rate countries and the impact of remittances on ratings is enhanced for small, low and middle income economies.

## Economy: Opportune time for major reforms to boost growth and reduce inequality in Colombia

## > 22-Dec-2010

Closing the income gap with the OECD and enhancing distribution of growth requires reforms in many fronts in Colombia. Better functioning labour and product markets and investment in skills and infrastructure would boost productivity, while well-designed social and education policies can reduce inequalities. In meeting these challenges this report examines how Colombia can draw on broad OECD policy experience and best practice in selected areas including education, infrastructure, competitiveness, labour markets and public finances.

## International Economic Forum Latin America & the Caribbean

## > 24-Dec-2010

The International Economic Forum Latin America and the Caribbean brings together leaders from public and private sectors to discuss the region's economic performance and share solutions to its development challenges. The third incarnation of the Forum was recently held on January 24th, 2011 and was co-organized by the OECD, the Inter-American Development Bank (IDB), and the French Ministry of Economy, Finance and Industry (MINEFI).

This year's forum focused on new factors of growth in Latin America and the Caribbean, in a world of shifting wealth, and included panels on the role of Latin America and the Caribbean within the G20 process, the opportunities and challenges of commodity trade, and the role of middle income sectors in development.

## Middle class in Latin America economically vulnerable, says OECD

## > 03-Dec-2010

Even though the growing middle class in Latin America is becoming an engine of economic progress, this group remains economically vulnerable when compared with high income OECD countries, according to the OECD Development Centre's Latin American Economic Outlook 2011. Therefore, Latin American governments must ensure that they do not fall down the economic ladder.
