

Revised Recommendation: main elements



EMBEDDING CULTURE CHANGE IN THE PUBLIC ADMINISTRATION IN SUPPORT OF COHERENCE

The Council recommended that:

Members maintain within their governance structures a framework to:

- Promote policy coherence for development, and translate commitment on PCD into practice;
- Work towards assessments of the impacts that domestic policies may have on wider development efforts



- Integration "We are committed to achieving sustainable development in its three dimensions... in a balanced and integrated manner." (Preamble).
- Long-term vision "We will implement the Agenda for the full benefit of all, for today's generation and for future generations." (Para. 18)
- Transboundary impacts and interconnectivity- "All of us will work to implement the Agenda within our own countries and at the regional and global levels... We acknowledge also the importance of ... interconnectivity in sustainable development." (Para. 21)
- Vertical coherence "Governments... will work closely on implementation with regional and local authorities, sub-regional institutions, international institutions..." (Para. 45).
- Stakeholder engagement "All countries and all stakeholders... will implement this plan" (Preamble).



Commitment and leadership – Guide whole-of-government action towards PCSD.

Policy integration - Maximise synergies & minimise trade-offs between economic, social and environmental goals.

Long-term vision – Make informed choices considering the implications of today's decisions.

Policy effects – Systematically consider the transboundary effects of policies, particularly on developing countries.

Policy coordination - Anticipate and resolve policy divergences.

Regional and local involvement – Align priorities, plans and policies at all government levels.

Stakeholder engagement – ensure that diverse actions by key stakeholder are aligned.

Monitoring and reporting adjust policies in light of negative effects.
