
Improving the Business Environment in Lebanon

- Lebanon experiencing impressive growth rates for the last three years
- Private sector to be allowed to play a greater role
- Growth to become more internally driven
- Bottlenecks and overlapping mandates need to be removed

Rules, regulations and cumbersome procedures delay private sector activity

- IFC ranking used as a tool for measuring performance
- PCM has formed a series of working groups to help develop solutions that will form the core of the GoL's investment climate reform agenda.

Objective 1: Streamline process and reduce cost of starting a business, and enhance transparency to public		
Process Streamlining and Automation	 Map and redesign business registration process Standardize incorporation documents Complete automation of commercial registry 	
Fee Structure	 Remove MoF's stamp fee Consider eliminating the mandatory use of legal counsel when establishing a company ("SARL") 	
Legislation	 Adopt a new law to create a single partnership company as a corporate structure Eliminate the minimum paid-in capital requirement

Objective 2: Fast track, reduce costs and increase transparency for construction permits		
Process Streamlining	Streamline and eliminate overlaps in construction permitting in Beirut and Tripoli and then all Lebanon	
Fee Structure	 Review fee structure and ensure service delivery against each cost incurred by applicant 	
Regulation	 Review and simplify system for building categorization Introduce risk thresh hold to clearly determine low-risk projects that could benefit from fast track processes Introduce mandatory time limits for granting permits 	
Public Information	 Provide guidelines, checklists and transparent information on construction permitting 	

Working Group 2: Construction Permitting

Objective 3: Ensure safety in construction and strengthen regulatory controls for construction permitting	
Regulation	➤ Introduce robust third-party review mechanism focusing on higher-risk building applications, to ensure compliance
Legislation	Complete building code and reference standards

Working Group 3: Access to Credit and Secured Lending

Objective 4: Modernize secured lending framework to facilitate access to credit	
Legislation	➤ Enact the modern law on Secured Finance Transactions
Awareness and Public Information	 Develop online collateral registry for movable assets and integrate with other asset registries Conduct awareness campaigns for stakeholders

Working Group 4: Trading Across Borders

Objective 5: Streamline, automate and reduce costs of trading across borders	
Process Streamlining	 Map and redesign procedures for import and export and reduce the list of documents required for customs clearance Create an electronic single window covering public and private entities Develop e-payment facilities Delegate inspections to Customs under a risk based system Develop in country logistics hubs/dry ports to address congestion at borders Synchronize and extend working hours across relevant public and private entities
Fee Structure	> Review and set port fees in transparent manner

Working Group 4: Trading Across Borders

Objective 6: Enhance regional and international trading relations

Legislation

- Expedite Lebanon's accession to WTO
- ➤ Sign mutual recognition agreement with the EU and other countries to ensure quality of imports with adequate level of inspection
- Review bilateral agreements with neighboring countries for trade and transit

Objective 7: Speed up commercial and civil proceedings and ensure faster trials		
Process Improvement	 Adopt and implement concept of "pre-trial' judge Implement fast track procedures such as "refere"/ payment injunction procedure Reduce grounds for objection to fasten execution process Develop electronic notification process between lawyers Limit availability of appeals before Court of Appeals and Court of Cassation 	
Institutional Improvement	Review the allocation of judges across regions	
Legislation	 Promulgate law for faster proceedings for small trials (less than LL15mill)

Objective 8: Ensure equitable and effective access to justice for citizens

Review judicial fee structure and introduce improvements to reduce costs of justice

Objective 11: Develop a supportive insolvency framework for businesses	
Process Streamlining	➤ Map and streamline insolvency procedures (NSSF and MoF)
Framework	Develop framework for out-of-courts workouts and gain bank approval on adoption
Regulation	 Develop a more robust entry process for insolvency practitioner profession Develop code of conduct and discipline mechanism for insolvency practitioner profession Review and adjust remuneration of insolvency practitioners
Legislation	Enact modern and updated bankruptcy law
