First International Advisory Group Meeting: Conclusions

- Acknowledged the progress made in the development of the project since the initial technical meeting in June, 2013.
- Agreed ToR for the IAG and in principle arrangements for the TAG
- Agreed on main technical issues and options for addressing these as well as draft component ToR for Strands A (cognitive assessment) and B (contextual questionnaires)
- Reviewed and discussed capacity needs analysis for the countries and progress with the design of capacity building programmes for the countries
- Agreed ToR for an independent review of the project in 2017
- Agreed a set of **next steps** for taking the project forward.

 OECD to sign participation agreements with all the countries participating in the project



- OECD has signed participation agreements with Ecuador, Guatemala, Senegal and Zambia
- Cambodia and Tanzania are processing agreements through their respective systems
- OECD is holding dialogues with **Paraguay** and **Morocco** regarding their possible participation in the project



Next steps and actions taken (4)

Next steps

 Participating countries to nominate National Centres and National Project Managers and to prepare project implementation plans



- **Ecuador, Guatemala, Senegal and Zambia** have nominated NCs
 and NPMs
- Cambodia and Tanzania have yet to nominate NCs and NPMs
- Fernando, Leonor and Satya
 are planning to support the
 preparation of PIPs in all six
 countries during November,
 December 2014 and January 2015
 – guidelines in English, French and
 Spanish have been distributed.



Next steps and actions taken (5)

Next steps

 Participating countries to finalise agreements with development partners regarding contributions and support (e.g. international costs, in-country costs and activities) and to finalise in-country budgets

- Actions taken in respect of international costs by Ecuador, Guatemala, Senegal and Zambia
- Cambodia and Tanzania are processing agreements with their respective development partners
- All countries are preparing incountry budgets and are being supported in this by capacity consultants, Fernando, Satya and Leonor, and the OECD



Next steps and actions taken (6)

Next steps

 OECD to complete capacity needs analysis and to design capacitybuilding programmes for all participating countries



- Capacity needs analysis completed for Ecuador, Guatemala,
 Senegal, Tanzania and Zambia
 - reports are being finalised
- Capacity needs analysis for
 Cambodia initiated from 29
 September
- Design of capacity building plans under way or scheduled in Ecuador, Guatemala, Senegal, Tanzania and Zambia
- Capacity building plan for Cambodia scheduled to be initiated from December



Next steps and actions taken (7)

Next steps

 OECD to finalise with development partners outstanding agreements for support to the project – general contributions and country-specific contributions



- All outstanding grant agreements finalised, with the exception of:
- 1. Norad addendum
- 2. DFID addendum
- 3. Irishaid contribution
- In discussions regarding possible increased contributions from Germany and Korea
- JICA and World Bank (using GPE resources) is providing support to Cambodia – under process
- DFID is providing support to Tanzania – under process



Next steps and actions taken (8)

 OECD to confirm with other agencies arrangements for technical partnerships and collaboration

- On-going dialogue with SACMEQ, PASEC, Pre-PIRLS, PIRLS, LLECE, STEP, LAMP, WEI-SPS, TIMSS and consideration of other relevant assessments such as ASER, EGRA/EGMA, UWEZO
- In addition to dialogue, ACER review of other assessments will be a vehicle for establishing potential for partnership
- Partnerships will be followed up once the international contractors are on board with particular focus on national components of Strand A; enhancement of questionnaires under Strand B; and Strand C
- UIS, UNICEF and EFA GMR collaboration over Strand C



Next steps and actions taken (9)

Next steps

 OECD to consult with IAG members on the ToR and membership of the TAG and the draft engagement and communication strategy

- ToRs endorsed by IAG and some written feedback on draft since meeting in May
- Agreement to make use of existing PISA TAG for PISA for Development
- OECD discussing with existing TAG members their willingness to take on PISA for Development responsibility – positive response thus far
- Will supplement TAG with additional experts with developing country focus and Strand C
- Written comments received on the draft engagement and communication strategy positive response

- Call for tender for Strands A and B launched on 4 August.
- Bids received by 29 September
- Technical review panel from 9-10
 October
- Questions to bidders: 13-17 October
- Technical review report and agreement on preferred bidder(s) by
 24 October
- 27 October 7 November IAG and PGB SDG review of technical review report
- PGB informed of technical review report 7-21 November
- ToR and contracts finalised by 21
 November
- OECD Procurement Board 26
 November
- Contracts signed by early December




- Project implementation:
