#### WHAT IS THIS CONFERENCE ABOUT?

The "Human Capital for Inclusive Growth in North Macedonia" conference aims to provide a high-quality exchange platform to policy and decision-makers, private sector representatives and experts to discuss how North Macedonia can build on its human capital – the skills, experience and talents of its citizens and its SMEs – to foster sustainable and inclusive growth of its economy.

Drawing on the key findings from the OECD South East Europe Division's latest publications, the conference is structured around two sessions. During the morning session, the OECD South East Europe Division will present and discuss the key findings and policy recommendations for North Macedonia of its report Labour Migration in the Western Balkans: Mapping Patterns, Addressing Challenges and Reaping Benefits. This report was launched at the OECD High Level Conference on Human Capital Flight – Shaping the Future Together (17 May, Paris) and benefitted from the support of Austria (ADA) and Switzerland (SDC).

\*This designation is without prejudice to positions on status, and is in line with United Nations Security Council Resolution 1244/99 and the Advisory Opinion of the International Court of Justice on Kosovo's declaration of independence.

Following the presentation of the report, a distinguished panel will focus on how the benefits from labour migration and the diaspora can be maximised for North Macedonia's own socio-economic development.

During the afternoon session, the OECD South East Europe Division will present the findings of its flagship publication SME Policy Index: Western Balkans and Turkey 2022 for North Macedonia. The regional publication was launched by the OECD Deputy Secretary General Ulrik Vestergaard Knudsen and the European Commissioner for Neighbourhood and Enlargement Olivér Várhelyi at the Dubrovnik Forum (8 July, Croatia). This publication contains detailed analyses on the progress and challenges in implementing the Small Business Act (SBA) for Europe and the discussions will aim to help policy makers in North Macedonia design and implement policies to strengthen enterprise skills and boost SME growth and resilience.

Following the presentation, a panel discussion on North Macedonia's potential to build on its entrepreneurial capital to boost enterprise growth and competitiveness will take place.

#### WHO WILL BE THERE?

The meeting will bring together policy-makers from North Macedonia, OECD and international experts, representatives from Austria, Switzerland, and the European Union, as well as representatives from the Chamber of Commerce, diaspora associations and other non-governmental and international organisations present in North Macedonia.
