



Created in 1984, its work is based on **consultation**, **dialogue and analysis**. Its action reinforces the coherence and effectiveness of interventions through the application of the Charter for Food Crisis Prevention and Management.

The Network brings together the three West African regional organisations (ECOWAS, UEMOA, CILSS), regional and international information systems, bi- and multilateral co-operation agencies, humanitarian organisations and international NGOs, as well as agricultural professional associations, the private sector and civil society.
