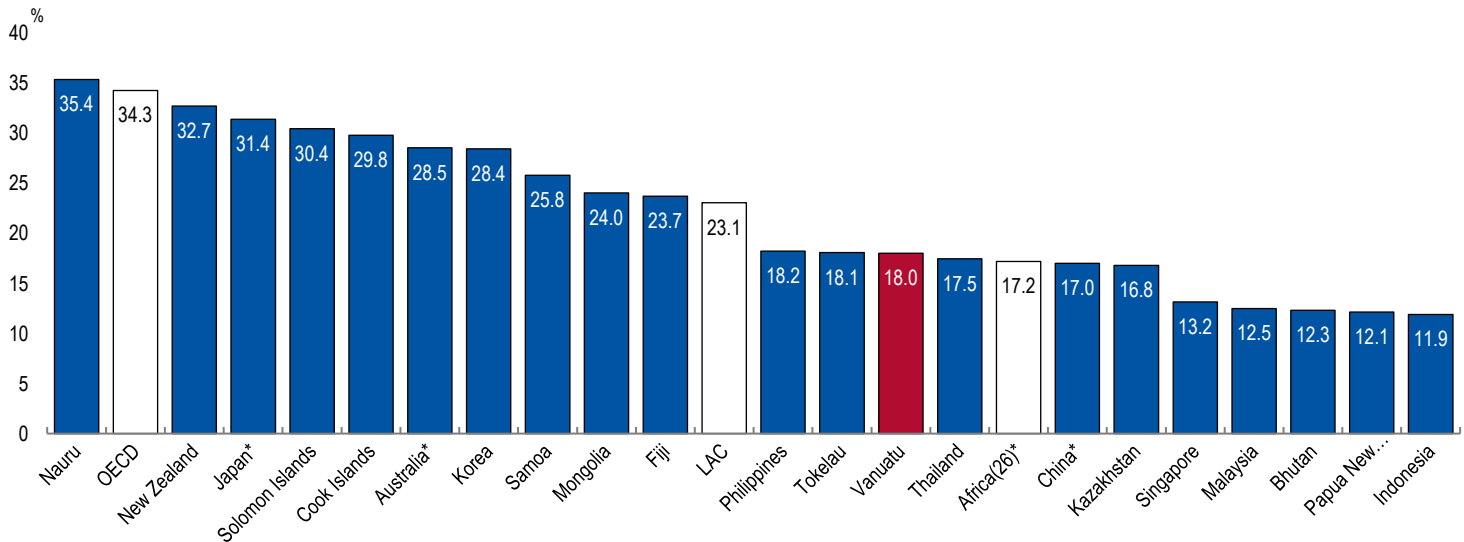


Revenue Statistics in Asian and Pacific Economies 2020 – Vanuatu

Tax-to-GDP ratio

Tax-to-GDP ratio compared to other Asian and Pacific economies and regional averages, 2018

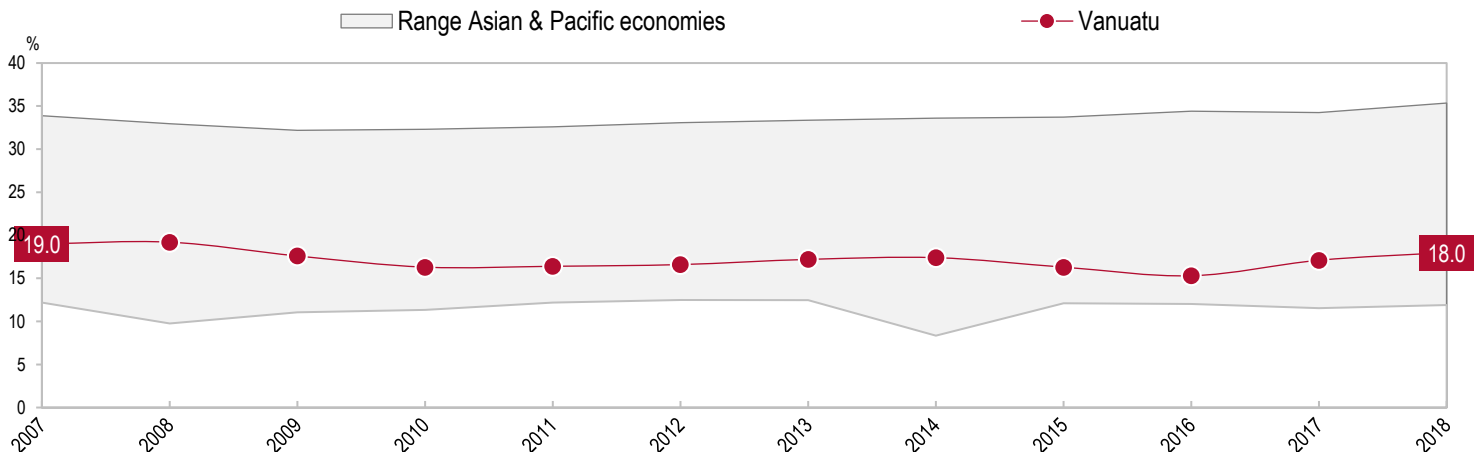
Vanuatu's tax-to-GDP ratio was 18.0% in 2018, below the OECD average (34.3%) by 16.2 percentage points, and also below the LAC and Africa (26)* averages (23.1% and 17.2%, respectively).



* Data for 2017 are used for the Africa (26) average, Australia and Japan as the 2018 data are not available. The tax-to-GDP ratio for China does not include revenue from social security contributions (SSCs) as detailed data were not available.

Tax-to-GDP ratio over time

The tax-to-GDP ratio in Vanuatu increased by 0.9 percentage points from 17.1% in 2017 to 18% in 2018. From 2007 to 2018, the tax-to-GDP ratio in Vanuatu decreased by 1.0 percentage point from 19.0% to 18.0%. The highest tax-to-GDP ratio in this period was 19.2% in 2008, and the lowest 15.3% in 2016.



In the OECD classification the term "taxes" is confined to compulsory unrequited payments to general government. Taxes are unrequited in the sense that benefits provided by government to taxpayers are not normally in proportion to their payments. <http://www.oecd.org/tax/tax-policy/oecd-classification-taxes-interpretative-guide.pdf>

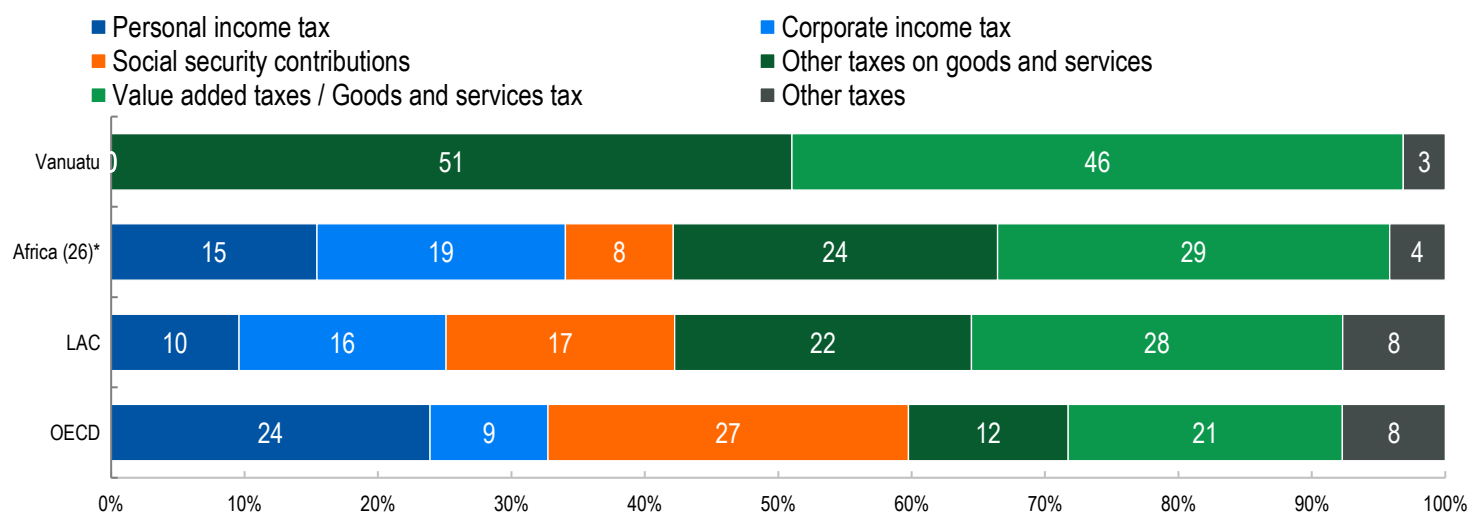

Tax structures

Tax structure compared to the regional averages

Tax structure refers to the share of each tax in total tax revenues. The highest share of tax revenues in Vanuatu in 2018 was derived from other taxes on goods and services (51.0%). The second-highest share of tax revenues in 2018 was derived from value added taxes / goods and services tax (45.8%).



* Data for 2017 are used for the Africa (26) average as the 2018 data are not available. All figures within the chart are rounded.

In this country note, "other taxes" is calculated as total tax minus taxes on income, profits and capital gains, social security contributions and taxes on goods and services. It includes taxes on payroll and workforce, taxes on property and other taxes (as defined in the OECD Interpretative Guide).
