

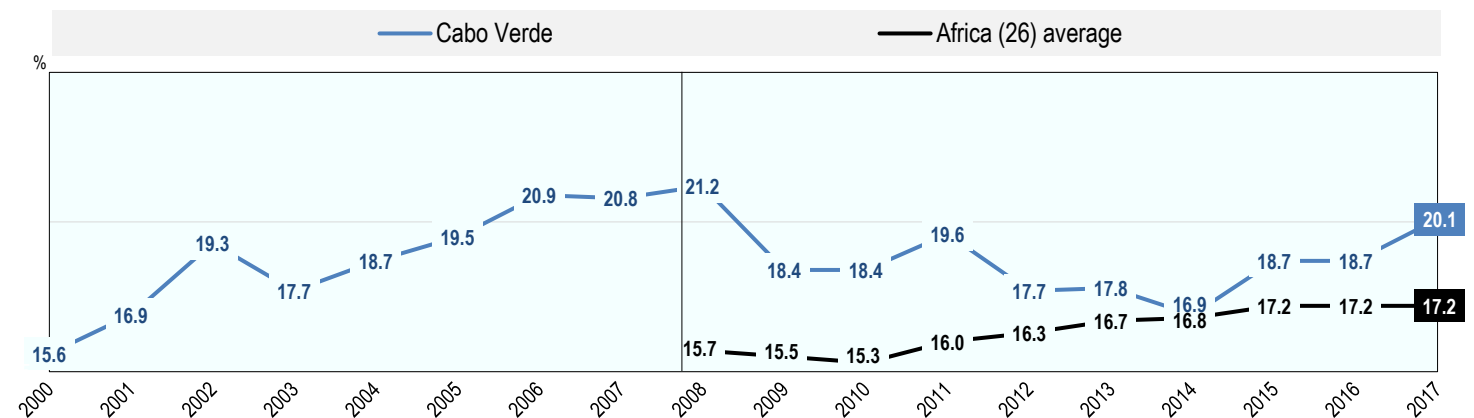


Revenue Statistics in Africa 2019 — Cabo Verde

Tax revenues: tax-to-GDP ratio

Tax-to-GDP ratio over time

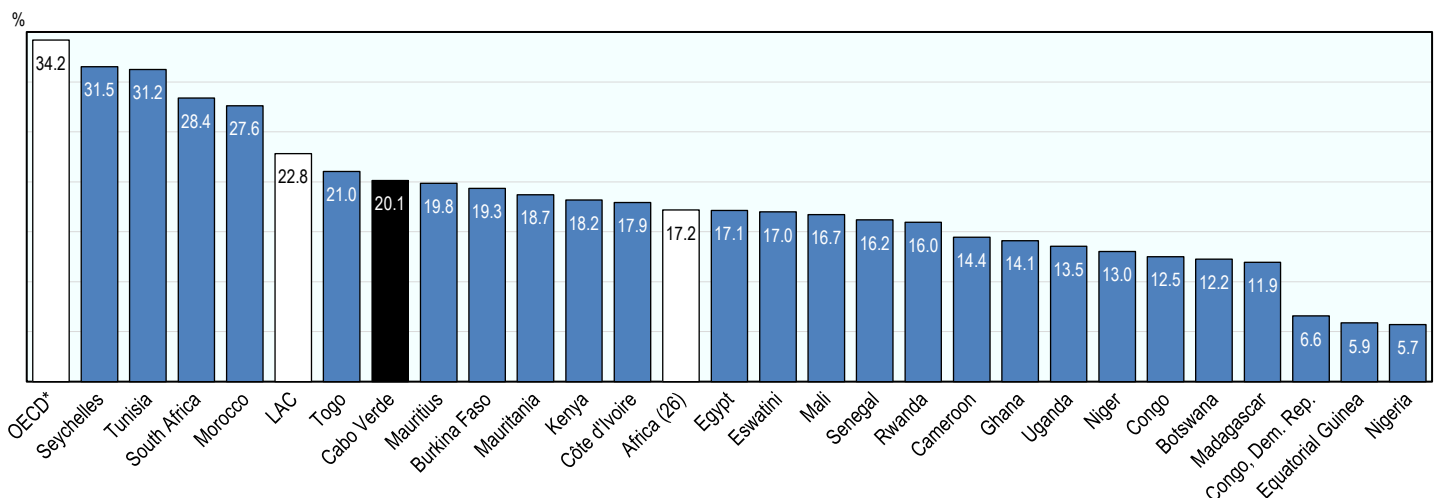
The tax-to-GDP ratio in Cabo Verde increased by 1.4 percentage points from 18.7% in 2016 to 20.1% in 2017. In comparison, the average for the 26 African countries in Revenue Statistics in Africa 2019 remained at 17.2% over the same period. Over a longer time period, the average for the 26 African countries has increased by 1.5 percentage points, from 15.7% in 2008 to 17.2% in 2017. Over the same period, the tax-to-GDP ratio in Cabo Verde has decreased by 1.1 percentage points, from 21.2% to 20.1%. Since 2000, the highest tax-to-GDP ratio in Cabo Verde was 21.2% in 2008, with the lowest being 15.6% in 2000.



The Africa (26) average is not available before 2008 due to missing data in some countries.

Tax-to-GDP ratio, 2017

Cabo Verde's tax-to-GDP ratio in 2017 (20.1%) was higher than the average of the 26 African countries in Revenue Statistics in Africa 2019 (17.2%) by 2.9 percentage points but lower than the LAC average (22.8%).

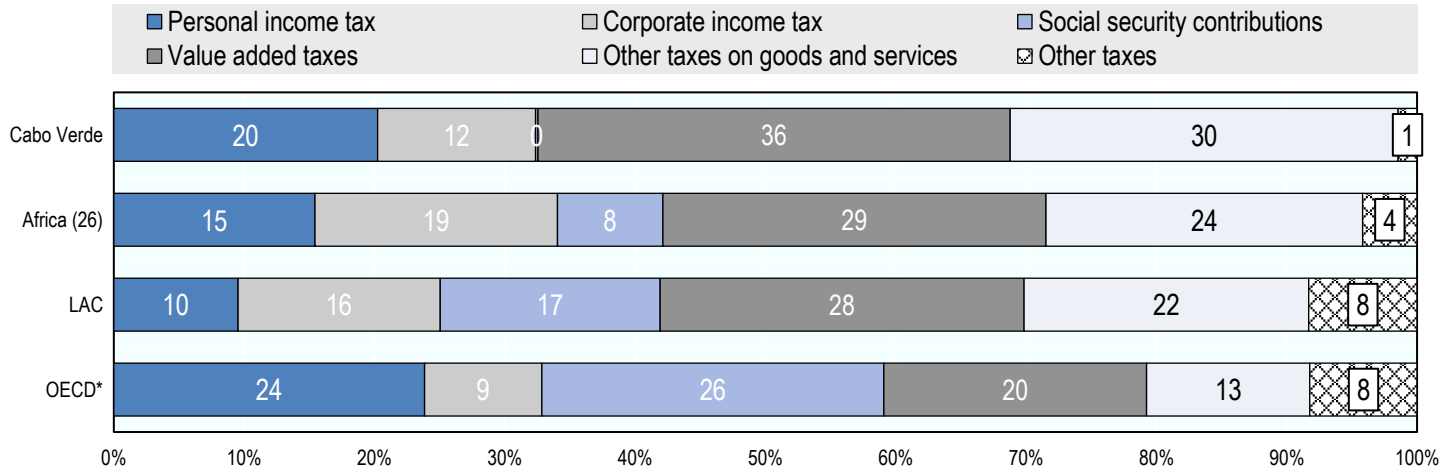
In the OECD classification the term "taxes" is confined to compulsory unrequited payments to general government. Taxes are unrequited in the sense that benefits provided by government to taxpayers are not normally in proportion to their payments. Tax revenues: structure

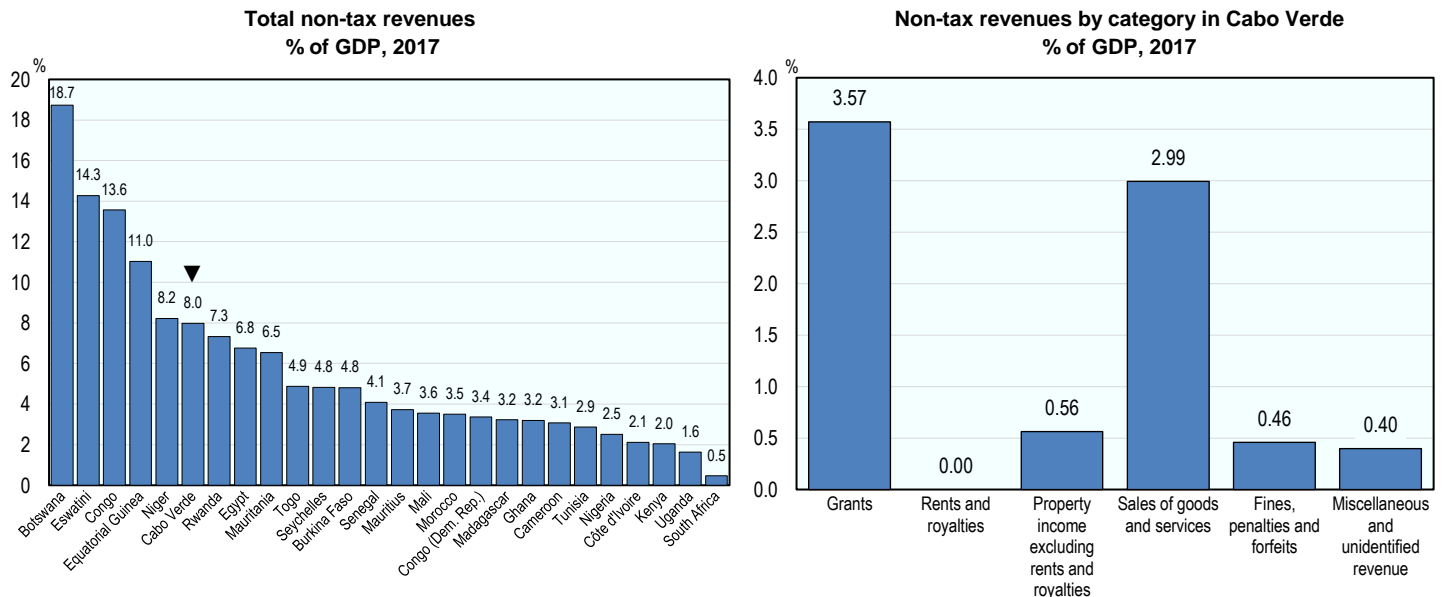
Tax structure refers to the share of each tax in total tax revenues. The highest share of tax revenues in Cabo Verde in 2017 was contributed by value added taxes (36%). The second-highest share of tax revenues in 2017 was derived from other taxes on goods and services (30%).

Non-tax revenues

In 2017, Cabo Verde's non-tax revenues amounted to 8.0% of GDP. This was lower than tax revenues (20.1% of GDP). Grants represented the largest share of non-tax revenues in 2017, amounting to 3.6% of GDP and 44.7% of non-tax revenues.
