Stephan Naundorf, Chair of the Regulatory Policy Committee

Stephan Naundorf has managed the cooperation of the German Government's Better Regulation Unit (BRU) with the regional governments, the parliamentary groups of the German parliament, the science sector in this field and the main umbrella organisations of the German Economy from 2006 through 2023. His scope of work has included the development of the Federal Government's programme for better regulation and to coordinate the cooperation of the German government on better regulation issues with international partners like France and supranational organizations like OECD or UNECE. Recently he has moved to the Federal Ministry of Defence, with a scope on the dialogue with societal groups and the science sector regarding an integrated concept of security.

His functions included that of a head of corporate communications for one of the international online pioneers. He also was member of the management board and shareholder of an advertising and public relations agency specialised on disruptive business models. His writings on Better Regulation have been published in Zeitschrift für Gesetzgebung, Tagesspiegel.de, Revue Française d'Administration Publique, Acteurs Publics, Legislation in Europe, and Lawmaking in multi-level settings.


Maija-Leena Paavola, Secretary General of the Parliament of Finland

Panel 1: Reflections on participatory, responsive and transparent rule-making in Finland



Anna Pietikäinen, Head of Division, Regulatory Policy, Public Governance, OECD

Anna has almost 20 years experience advising governments with the OECD and the United Nations. As Head of the Regulatory Policy Division, she leads the Organisation's work supporting member countries' regulatory reform and better regulation agendas through its Regulatory Policy Committee (RPC). Previously she led the secretariat of the OECD Network of Economic Regulators (NER).

Tiina Astola, former Director General at the European Commission

Tiina Astola, former Director General at the European Commission, has worked with drafting legislation at the Finnish Ministry of Justice (1986-1988 and 1992-2015), Ministry of Finance (1991-1992) and finally at the Directorate-General of Justice and Consumers (2016-2020) in different roles and on different fields of law. In the 1980's and early 1990's she was involved in drafting the first legislation on Securities Markets and an EU-reform of corporate law in Finland. In addition to her management role as the head of the European Law Unit and later the Civil Law unit at the Ministry of Justice she was personally responsible for negotiating the EU Regulation on Access to Documents at the Council Working Group and for drafting legislation on Assisted Infertility Treatment. As the Permanent Secretary of the Ministry of Justice (2007-2015) she had the overall responsibility for both international and domestic law matters. The role of Director General took this responsibility to the EUlevel.



Jennifer Brown, Director, Regulatory Policy and Stakeholder Relations, Treasury Board of Canada Secretariat

Jennifer is an experienced regulatory policy professional. Her team within Regulatory Affairs of the Treasury Board leads strategic advice and projects to support the Government of Canada regulatory system. Christiane Arndt leads the OECD Regulatory Policy Outlook and the OECD Programme on Measuring Regulatory Performance, ranging from work on crosscountry comparable indicators to advice on domestic policy evaluation. Breakout session #1 – Role of parliament in better regulation



Paul Davidson, Policy Analyst, Regulatory Policy Division, OECD

Paul commenced working in the OECD Measuring Regulatory Performance team in 2018. Apart from contributing to flagship publications such as the *Regulatory Policy Outlook* series, he also provided substantive research assistance to the *OECD Best Practice Principles on ex post evaluation*, and led the update of the indicators of Regulatory Policy and Governance (iREG) survey to reflect the deepened understanding on ex post evaluation. He was the main author of the *OECD Best Practice Principles on One-Stop Shops for Citizens and Business*, and has contributed to other publications across the division on regulatory policy.

Korkea-aho is Professor of European Law and Legislative Studies at the University of Eastern Finland (UEF), PI of Research Council of Finland funded research project on revolving doors and its regulation (REVOLVE, 2021-2025), and the Kone Foundation research project on political influence and lobbying in Finnish municipal politics (LoSKa, 2023-2026). Her research interests relate to law and democracy in the EU and national contexts, with a focus on EU institutional and constitutional law. She has written about soft law, legal expertise, lobbying and the revolving door phenomenon, and the national governance of EU structural funds. She is a co-editor of EU Soft Law in the Member States (Hart Publishing, 2021), of Law, Legal Expertise and EU Policy-Making (Cambridge University Press, 2022), and of Research Handbook on Soft Law (Edward Elgar, forthcoming 2023). Korkea-aho has served in various expert positions relating to lobbying and its regulation. As of June 2023, she has served as Vice-Chair of the

Advisory Board for the Finnish Transparency Register. In 2020, she received the Academy of Finland Award for Social Impact in recognition for her work on lobbying.



Roger Kuettel, Senior Advisor, Regulatory Policy and Analysis, State Secretariat for Economic Affairs (SECO), Switzerland

Roger works as senior advisor in the Regulatory Policy and Analysis Unit of the State Secretariat for Economic Affairs (SECO) in Switzerland. The unit is the federal government's centre of expertise for Regulatory Impact Assessments (RIA), providing practical guidelines, carrying out RIA, and assisting federal offices in their analysis. In addition, the unit responds to parliamentary requests related to RIA, regulatory policy and regulatory instruments for easing the burden on businesses.

Roger joined SECO in 2016. Most recently, he focused on the drafting of two parliamentary bills, a "regulatory brake" to be anchored in the constitution and a federal law on the reduction of regulatory cost for businesses, both of which are currently being debated in the Swiss parliament.

Nils Björksten, Visiting Professor, College of Europe


