Introduction

This is the Italian contribution to OECD Committee for Fisheries project "Fisheries Subsidies and Sustainable Development".

In the last years, two main programmes have been developed:

- the programme supported by the EU structural fund FIFG (Financial Instrument for Fisheries Guidance) that covers the period 2000-2006 and
- the programme based on National Triennial Plans. These Plans call for the rationalisation and development of the whole fishing industry where not only short and medium term targets, but also long term considerations are included. Until now, seven National Triennial plans were enforced.

The first programme financing by FIFG covers eleven main areas:

- 1. Decommissioning schemes
- 2. Fleet renewal and modernisation of fishing vessels
- 3. Protection of marine resources in coastal waters
- 4. Aquaculture
- 5. Fishing port facilities
- 6. Processing and marketing of fishery an aquaculture products
- 7. Small-scale coastal fishing
- 8. Socio-economic measures
- 9. Measures to find and promote new market outlets
- 10. Operations by members of the trade
- 11. Innovative actions and technical assistance

Other financial resources are allocated through the National Triennial Plans. Funds allocated by the Directorate General for fishing and aquaculture of the Ministry for Agricultural and Forestry Policies (Mipaf) are addressed to:

- 1. Compensation for closed seasons
- 2. Compensation for damage to the fishery sector
- 3. Support to promotion and marketing
- 4. Interest rebates and loan guarantees
- 5. Management expenditure
- 6. Research expenditure

- fishermen who can show that they have worked for at least five years as fishermen, to help them retrain or diversify their activities outside maritime fisheries under an individual or collective social plan,
- to fishermen younger than 35 years who can demonstrate that they have worked at least five years as fishermen or can demonstrate equivalent vocational training and who acquire for the first time part or total ownership in a fishing vessel, provided that the following conditions are fulfilled:
- i. the fishing vessel must have an overall length between 7 and 24 metres; at the time of acquisition of ownership it must be aged between 10 and 20 years, it must be operational and it must be registered in the fishing vessel register of the European Community;
- ii. the transfer of ownership does not occur within the same family up to the second degree. 'small-scale coastal fishing' (vessels of an overall length of less than 12 metres)
