Answers are given in sequence of value chain elements in a table format.

The eight questions are as follows :

- **Question 1** : Is the service provided by the public or private sector?

- **Question 2** : Does a cost recovery scheme exist?
Y (yes), N (no), P (partially)
- **Question 3** : Is the provision of a service regulated?
Y (yes), N (no), P (partially)
- **Question 4** : On what grounds is the provision of services restricted?
E (environment), M (management), C (Conservation), Security (S), O (others)
- **Question 5** : Are domestic and foreign users treated equally?
Y (yes), N (no)
- **Question 6** : Is the service provided as a regulatory obligation?
Y (yes), N (no)
- **Question 7** : Can the user freely choose between domestic or foreign providers?
Y (yes), N (no)
- **Question 8** : Is the provision of a service an outcome of internationally agreed measures?
