

# Breaking away from "tradition" Labour Issues in the shipbuilding and marine equipment industries

C-WP6 Workshop Tuesday, 21 November 2023 9:30 – 18:00 (CET) OECD Headquarters, Paris (with possibility of Virtual Participation)

### Background

At its 10-11 May 2023 meeting, the OECD Council Working Party on Shipbuilding (C-WP6) agreed that its next workshop would focus on labour issues in the shipbuilding industry.

The workshop does not intend to focus on any agreement or understanding that unduly reduces competition or unreasonably restrains trade. A statement of Compliance with Anti-trust and Competition Laws will be read at the beginning of the Workshop.

### Objective

Labour has become a key and critical issue for shipyards given the need for new skills in the context of the green and digital revolutions affecting the maritime sector. Moreover, the shipbuilding and marine equipment industries compete with other sectors to attract talents in particular young people and women.

Against this backdrop, this workshop aims to better understand the labour situation in the shipbuilding sector and to exchange information on policy measures taken by governments and actions taken by the private sector to address these challenges.

Finally, participants in this workshop will be invited to discuss about future actions to be taken involving possibly international cooperation to address labour Issues in the maritime sector.
