Boosting the social entrepreneurship ecosystem in Luxembourg

■ What's the issue?

Social entrepreneurship aims to address social and societal problems in an entrepreneurial way. It offers innovative ways of dealing with social, economic, and environmental challenges while fostering inclusive growth. It can contribute to job creation and improvements in the delivery of welfare services, as well as to civic participation.

Among other entities populating the field of social entrepreneurship, "social enterprises" (regardless of their legal form or status and of the way they are called accross countries) aim to have a specific social impact through their economic activities and reinvest a significant part of their profit to achieve their social mission. They also commit to transparent and participatory governance, involving their relevant stakeholders.

Because of these caracteristics, social enterprises might face specific challenges and need specific support to fulfil their potential. This is why it is important to establish conducive ecosystems to stimulate their development. Policies for social entrepreneurship can raise the visibility of social enterprises and facilitate their formal recognition, as well as their access to markets and to finance.

In Luxembourg, the entry into force of the Law of December 12th, 2016, on societal impact companies, contributed extensively, not only to the national recognition of the social and solidarity economy, but also to create the necessary legal foundations for the development of the sector. The legal framework stems directly from the principles defined at the European level by taking into account the specificities of the national environment. Despite the recent emergence of a complete ecosystem dedicated to the social and solidarity economy, key issues remain.

■ About the workshop

This workshop will bring together relevant stakeholders from Luxembourg as well as international experts on social entrepreneurship to assess and discuss the key challenges and levers to build a conducive environment for social enterprises development in Luxembourg. In particular, participants will be invited to use the Better Entrepreneurship Policy Tool and will take away new insights on:

- → What are the challenges and opportunities identified from the self-assesment?
- → How should public policies help to deliver stronger outcomes in terms of environment for social enterprises development?
