The project

The programme is organised in coordination with the Prime Minister's Office (PMO) in the framework of the EU-funded project* "Support the Palestinian Authority to enhance Governance and the Rule of Law" (2020-2024) implemented by the OECD. The overall objective of the project is to support the Palestinian Authority and contribute to achieving a more effective, transparent and participatory policy- and law-making process set in a clear normative framework, and thus enhance citizens and businesses trust in their government's action. More specifically, the project will aim at enhancing the capacity of law and policy-makers to:

- Produce clear, effective and transparent primary and secondary legislation,
- Use efficient public consultation mechanisms as part of the policy development process, and
- Develop (and improve) online tools providing access to adopted and draft legislation.

*The project is implemented with funding by the European Union.

The activity

This builds on two sets of capacity-building activities organised in 2022 to support relevant staff from policy and legal units across public institutions as well as representatives from nongovernmental organisations to enhance the early stages of policy- and law-making process (i.e. institutional coordination, problem identification and assessment, policy formulation). It is also set in the continuity of the on-site coaching programme, conducted with the Ministry of Justice, on regulatory impact assessments for draft regulations in the judicial sector. In addition, the activity is in line with the priorities and needs set out by the PA during the High Level Conference on Rule of Law, Governance and Public Administration in Palestine on 27-28 September 2022 and the project's Stakeholders Advisory Group meeting of 29 September 2022.

This Project is Funded by



This programme will be organised between 22-23 February 2023 and will focus more specifically on <u>ex ante regulatory impact assessments</u> for draft policies and legislations, to support the uptake and effective implementation of the Review's recommendations (especially in Chapter 8) and Manual's practices (especially Practice 2). The primary objective is to strengthen capacities within the Palestinian public administration in conducting impact assessments for draft regulations, with a particular focus on financial, social and transversal impacts, such as on the environment or specific groups (women, youth, etc.).

The activities will be delivered by a local expert (in-person). Peers from OECD member countries will intervene remotely to share best practices from OECD countries in terms of policy and legislative development.
