The OECD Eurasia Competitiveness Programme was launched in 2008 to support thirteen Eurasia economies in developing more vibrant and competitive markets. It includes seven countries from Central Asia and six countries from Eastern Europe and the South Caucasus. The Programme's approach leverages OECD instruments and tools in order to assess where and how to enhance the **competitiveness** of countries, sectors and regions to generate **sustainable growth**. Since its inception, the Programme has developed and implemented several regional and country-specific competitiveness strategies, complemented by capacity building seminars and coaching for policy makers.

## Objective and approach

In order to support the successful implementation of Ukraine's decentralisation reform the project will provide both **analytical inputs** (analysis and policy recommendations) and **capacity-building activities** through a series of seminars in Kyiv and selected Oblasts, for public actors at different levels of government, as well as business community, academics and civil society involved in the decentralisation process.

The main objectives of the project will be to:

- update **territorial analysis** and performance indicators (with respect to the OECD 2014 report)
- assess **the progress and challenges** in the implementation of the decentralisation reform
- formulate **recommendations** for more effective multi-level governance based on an in-depth analysis of one or two **specific sectors**
- enhance **engagement with OECD** bodies and dissemination of project findings.



## Expected results and main activities

The **analytical inputs** will comprise a report together with high-level meetings focusing on:

- Ukraine's recent territorial development and performance, including updated key territorial indicators
- Ukraine's decentralisation reform challenges and mechanisms to address these gaps
- case studies of sector decentralisation, highlighting OECD good practices, and including recommendations for enhanced multi-level governance in the selected areas.

The findings and recommendations will be published in a final **OECD Report** to be discussed at the Regional Development Policy Committee (RDPC). The report will be launched at an **international conference** to be held in Kyiv in Spring 2018.

The **capacity-building activities** will include eight seminars in Ukraine as well as a study visit to Flanders and the EU Institutions for Ukrainian officials and policy makers to discuss territorial planning and service delivery.



## Partners and beneficiaries

The OECD Project will engage stakeholders at all levels of government and make recommendations for their benefit. Some of the key partners and beneficiaries will be:

- Ministry for Regional Development, Building and Housing of Ukraine (lead ministry)
- Ministry of Finance, all other line ministries
- regional authorities (including associations)
- elected and administrative staff at oblast, rayon and hromada level
- citizens of Ukraine, who will benefit from more effective and efficient operation of sub-national governments.
