■ What's the issue?

In the framework of the OECD work stream *Preparing Regions for Demographic Change*, the project *Strategic Governance Plan for Rural Depopulation in RESOE* aims to help policy makers manage the challenge of demographic change. The RESOE macro-region (regions of Asturias, Cantabria, Castilla y León and Galicia in Spain) has a high degree of rurality, and is facing challenges associated with population decline and ageing. The project provides national, regional and local stakeholders with an action plan for each region and a common strategy for the four regions on relevant topics to OECD rural regions facing depopulation: quality service provision, entrepreneurship, innovation, digitalisation, and multi-level governance.
