Leveraging the assets of the region as a whole can boost investment. Optimising value chains across South East Europe in the context of global competition can help policy makers to increase the competitiveness of their economies and achieve more inclusive growth. A move up the value chain can enable the region to compete in a sustainable way, in order to create more and better jobs. This implies enhanced investment in human capital development and retention, implementing policies and instruments in favour of the creation and absorption of knowledge.
