OVERVIEW

The Organisation for Economic Co-operation and Development (OECD) and the ASEAN Secretariat are pleased to organise the 7th meeting of the OECD-ASEAN Regional Policy Network on SMEs on 16 May 2017, in Kuala Terengganu, Malaysia. The objective of the meeting is to learn more about the ingredients of successful policies for inclusive business and ways to promote women entrepreneurship in ASEAN. The meeting will provide opportunities to discuss constraints and share good practice examples. The meeting will feature invited experts from OECD and ASEAN member countries.

STRUCTURE

The meeting will have three sessions:

Session 1

: Inclusive Business (IB) in ASEAN: *Overview and Case Studies* session will introduce the concept of IB and highlight relevant examples across the region. The discussion will cover the relevance of IB for ASEAN, and the case studies will illustrate successful IB models across three MSME contexts: (1) IB models implemented by Medium enterprises; (2) IB models integrating Micro and Small Enterprises (MSEs) in their value chain (e.g. as suppliers or distributors); and (3) social enterprises that have scaled to become IB.

Session 2

: *Promotion of inclusion session* will focus on the recent work of OECD that touches the issue of inclusion of SMEs. This session has been designed to inspire the ASEAN policy makers with the recent work conducted by OECD.

Session 3

: Women Entrepreneurship in ASEAN session will focus on the presentation of the ASEAN OECD study on women entrepreneurship. While women in Southeast Asia have made considerable gains in education – and in some countries outstrip men in tertiary enrolment – this has not translated into full access to employment or entrepreneurship. The session will provide an opportunity for exchange and discussion on gender policy challenges in education, employment, and entrepreneurship in ASEAN. It will feature invited experts from the ASEAN Committee on Women and the ASEAN Women Entrepreneurs Network.

CONTEXT

Held in connection with the 3nd meeting of the ASEAN Co-ordinating Committee on MSMEs (ACCMSME), this meeting is part of the *OECD Southeast Asia Regional Programme*, launched in 2014 to support regional economic integration and policy reforms in the countries. The Regional Policy Network on SMEs is a mutual learning platform for Southeast Asia and the OECD.

The Regional Policy Network on SMEs comprises of delegates from ASEAN and OECD member countries. The experts from OECD, ASEAN Secretariat as well as invited experts from the Member Countries are invited to the meeting in order to present relevant initiatives and projects.

15:30 –16:15 Session 2: Promoting a more inclusive environment for SMEs

SME policies work at levelling the playing field in the face of specific market, government and systemic failures faced by SMEs as they attempt to compete and scale. SMEs make up over 90% of enterprises in ASEAN and account for 58-91% of the workforce. They are also an important driver of innovation, job creation and service-sector productivity growth globally. Consequently, improving the environment for SMEs to enter, compete and thrive or fail and exit will be critical for future ASEAN integration, inclusive growth and economic upgrading. This session will focus on recent studies conducted by the OECD that look at promoting economic inclusion by improving the enabling environment for SMEs – for instance by improving their access to credit or enhancing their market access through greater participation in Global Value Chains. The session will provide concrete policy recommendations for and findings from ASEAN countries.
