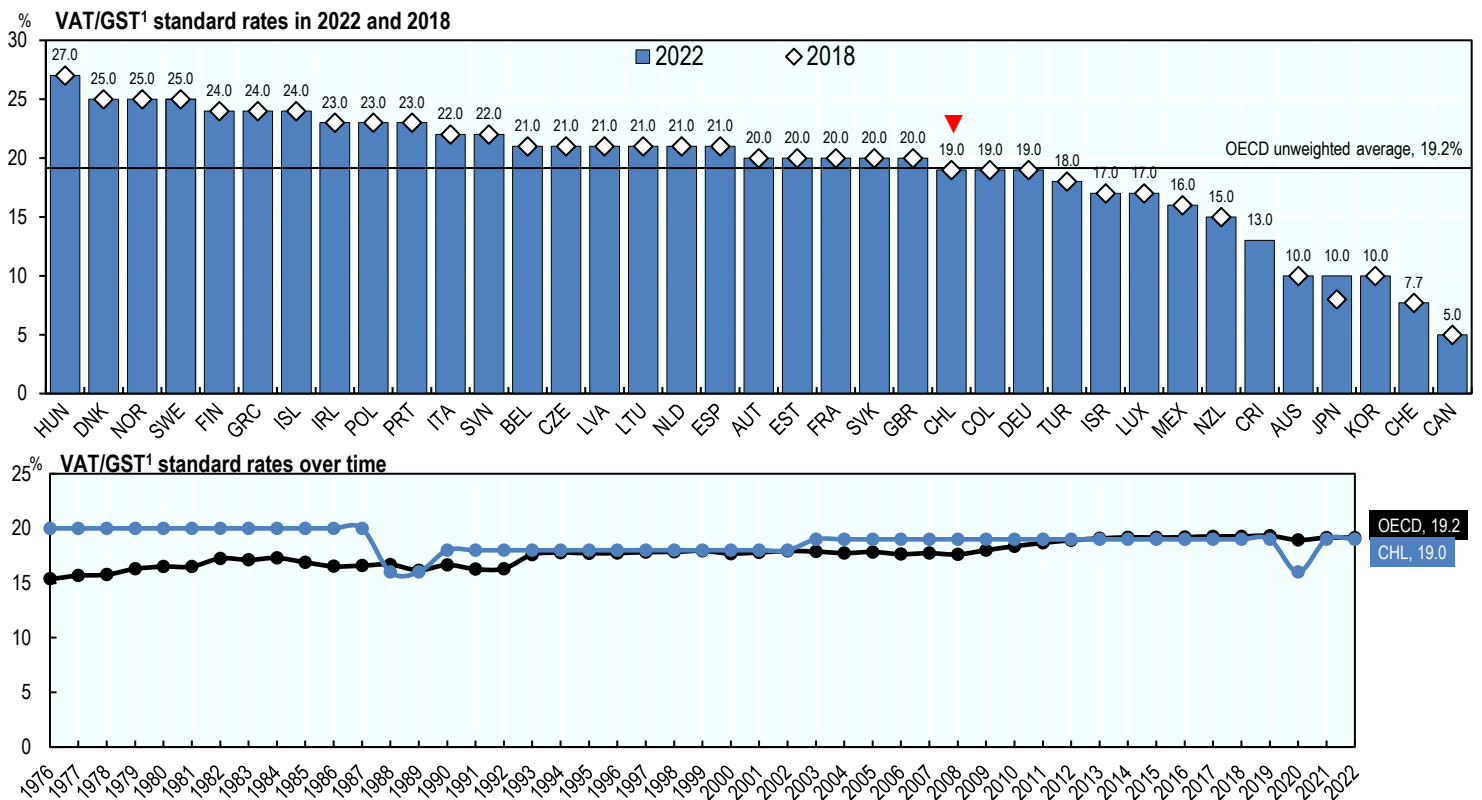


## Consumption Tax Trends\* - Chile

### VAT rate 2022

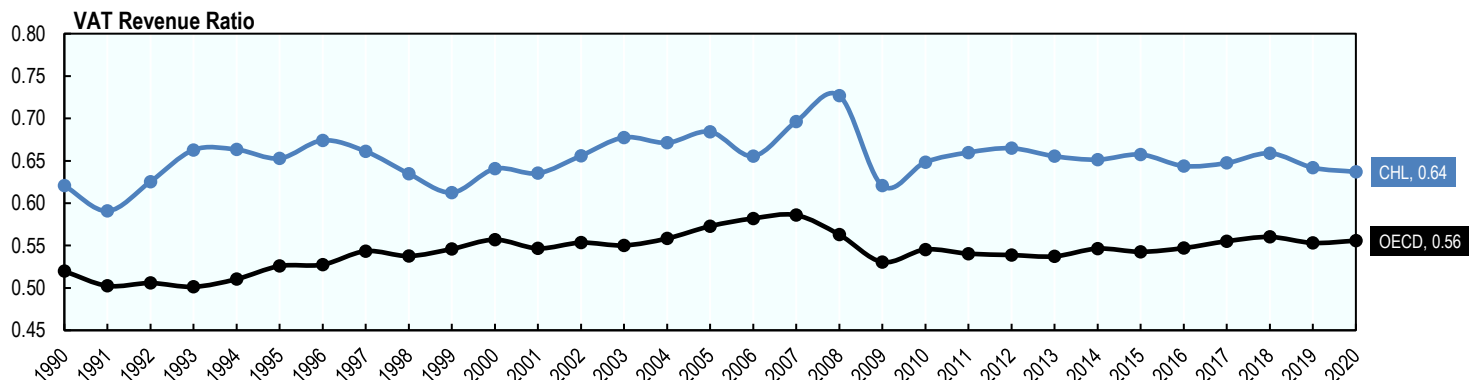
The Chilean standard VAT rate is 19.0%, which is close to the OECD average. The average VAT/GST<sup>1</sup> standard rate in the OECD was 19.2% as of 31 December 2022. The previous standard VAT rate in Chile was 16% in 2020. It changed to the current level in 2021. Chile does not have any reduced rates. VAT was introduced in Chile in 1975 at a standard rate of 20.0%. Since then the minimum and maximum standard rates have been at 16.0% and 20.0% respectively.

### VAT Revenue Ratio

The VAT Revenue Ratio (VRR) for Chile was 0.64 in 2020, above the OECD average of 0.56. The VRR is a measure of the revenue raising performance of a VAT system. A ratio of 1 would reflect a VAT system that applies a single VAT rate to a comprehensive base of all expenditure on goods and services consumed in an economy - with perfect enforcement of the tax. The Chilean VRR decreased from 0.66 in 2018 to 0.64 in 2020. The lowest VRR was recorded in the year 1991 at 0.59 and the highest level in 2008 at 0.73.

They notably include the recommended principles and mechanisms to address the challenges for the collection of VAT on cross-border sales of digital products that had been identified in the context of the OECD/G20 Project on Base and Erosion and Profit Shifting (the BEPS Project).
