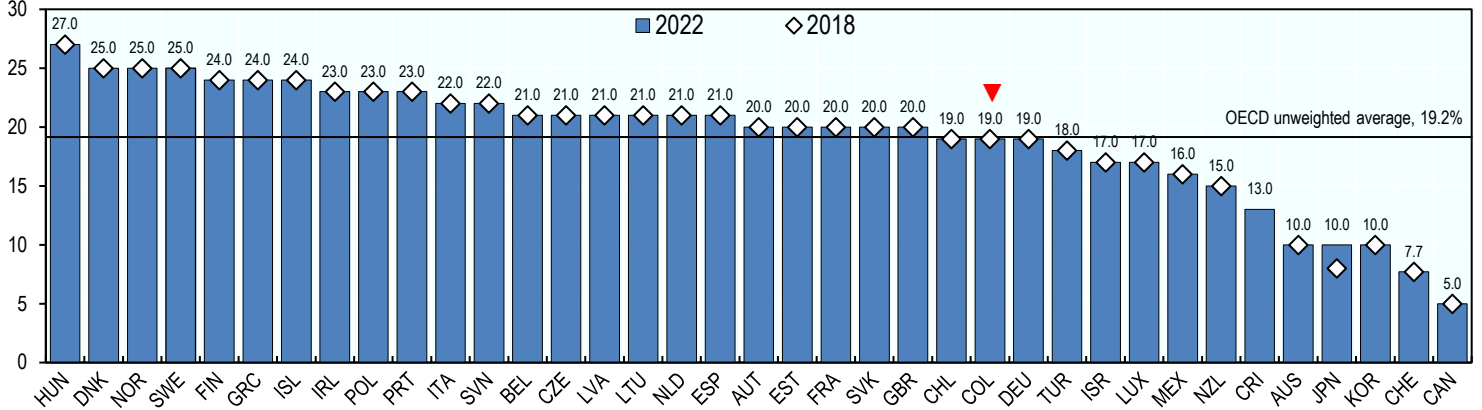


## Consumption Tax Trends\* - Colombia

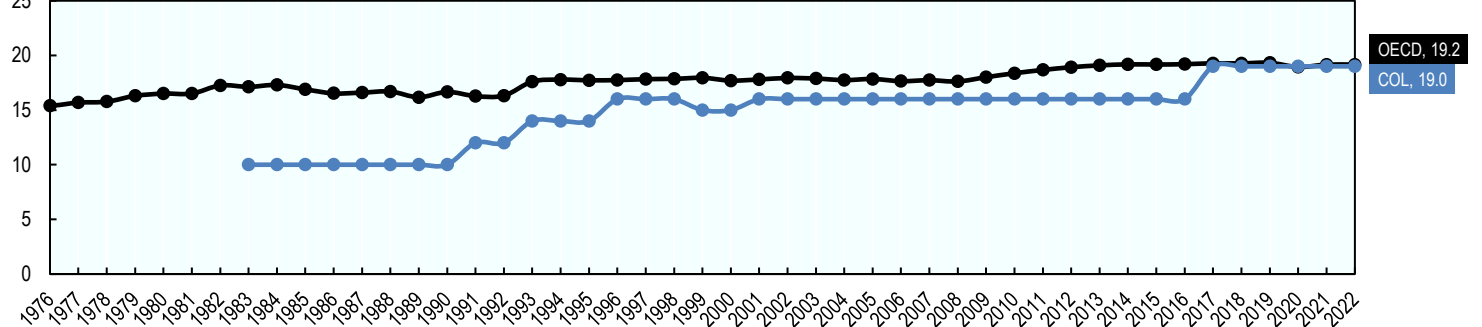
### VAT rate 2022

The Colombian standard VAT rate is 19.0%, which is close to the OECD average. The average VAT/GST<sup>1</sup> standard rate in the OECD was 19.2% as of 31 December 2022. The previous standard VAT rate in Colombia was 16% in 2016. It changed to the current level in 2017. Colombia applies reduced VAT rates of 0% and 5% to a number of goods and services. Temporary specific reduced VAT rates applied in the context of the Covid-19 pandemic between April 2020 and December 2022. VAT was introduced in Colombia in 1983 at a standard rate of 10.0%. Since then the minimum and maximum standard rates have been at 10.0% and 19.0% respectively.

**VAT/GST<sup>1</sup> standard rates over time**

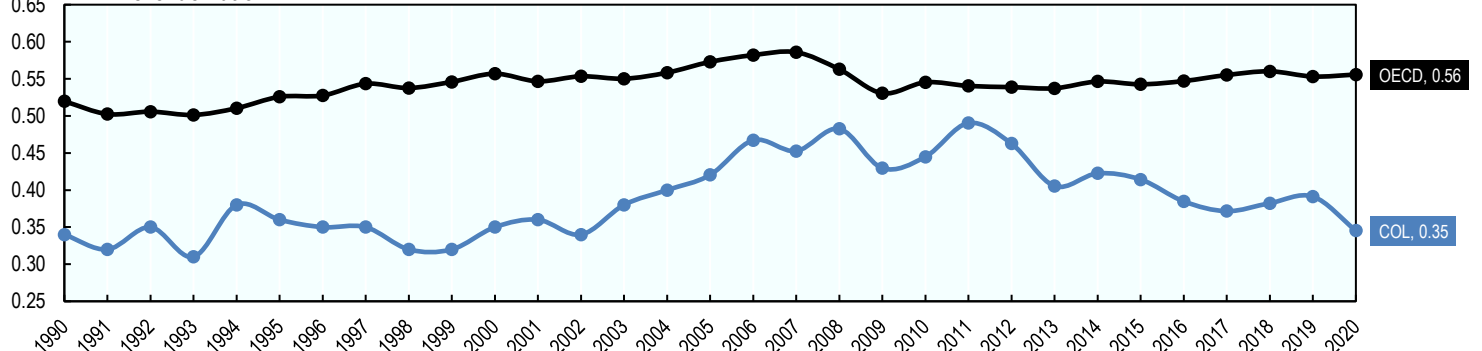


1. VAT/GST refers to value added tax/goods and services tax

### VAT Revenue Ratio

The VAT Revenue Ratio (VRR) for Colombia was 0.35 in 2020, below the OECD average of 0.56. The VRR is a measure of the revenue raising performance of a VAT system. A ratio of 1 would reflect a VAT system that applies a single VAT rate to a comprehensive base of all expenditure on goods and services consumed in an economy - with perfect enforcement of the tax. The Colombian VRR decreased from 0.38 in 2018 to 0.35 in 2020. The lowest VRR was recorded in the year 1993 at 0.31 and the highest level in 2011 at 0.49.

They notably include the recommended principles and mechanisms to address the challenges for the collection of VAT on cross-border sales of digital products that had been identified in the context of the OECD/G20 Project on Base and Erosion and Profit Shifting (the BEPS Project).
