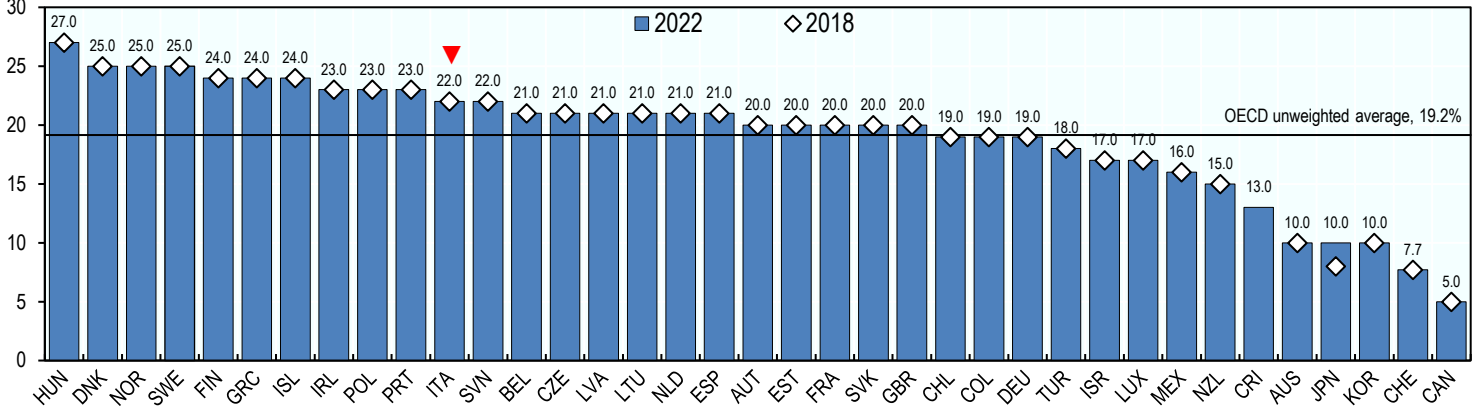


## Consumption Tax Trends\* - Italy

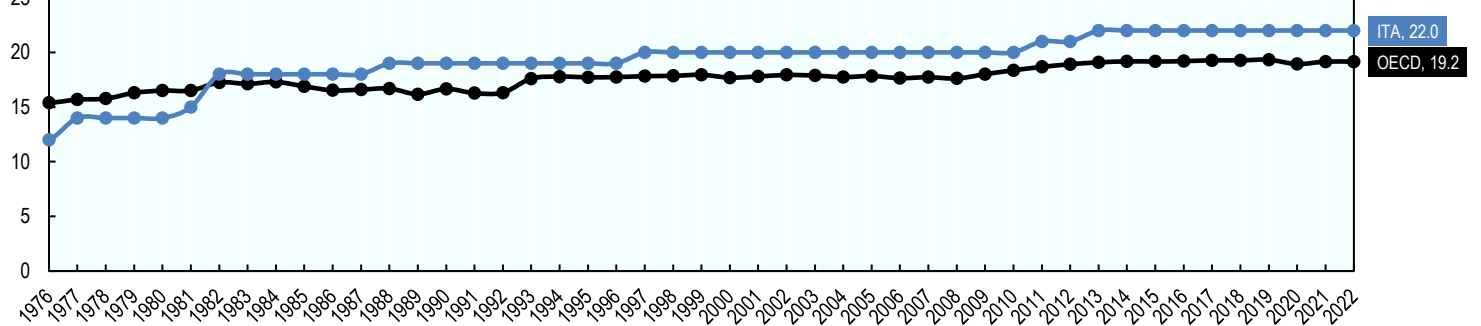
### VAT rate 2022

The Italian standard VAT rate is 22.0%, which is above the OECD average. The average VAT/GST<sup>1</sup> standard rate in the OECD was 19.2% as of 31 December 2022. The previous standard VAT rate in Italy was 21% in 2012. It changed to the current level in October 2013. Italy applies reduced VAT rates of 4%, 5% and 10% to a number of goods and services. Temporary specific reduced VAT rates applied in the context of the Covid-19 pandemic until September 2022. Temporary specific reduced rates were also introduced in 2022 to counter raising energy costs. VAT was introduced in Italy in 1973 at a standard rate of 12.0%. Since then the minimum and maximum standard rates have been at 12.0% and 22.0% respectively.

**VAT/GST<sup>1</sup> standard rates over time**

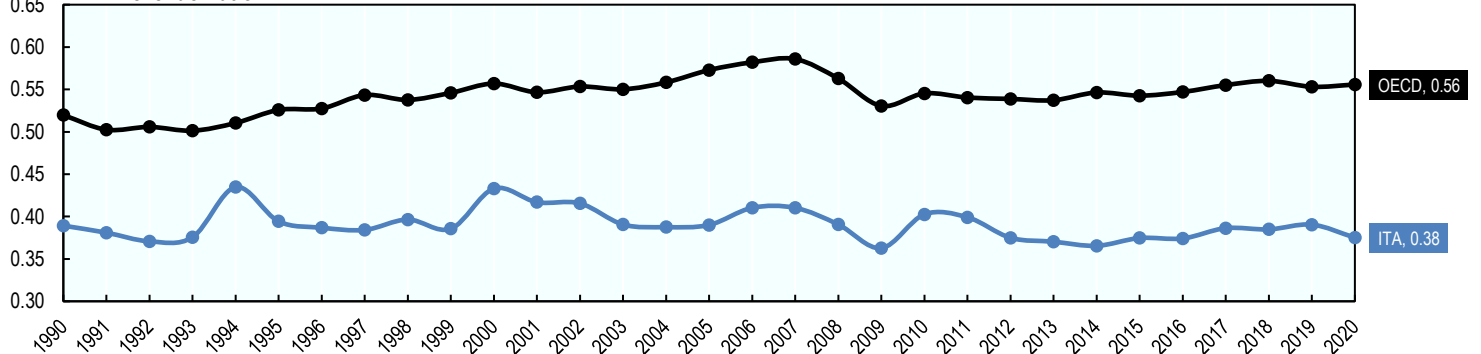


1. VAT/GST refers to value added tax/goods and services tax

### VAT Revenue Ratio

The VAT Revenue Ratio (VRR) for Italy was 0.38 in 2020, below the OECD average of 0.56. The VRR is a measure of the revenue raising performance of a VAT system. A ratio of 1 would reflect a VAT system that applies a single VAT rate to a comprehensive base of all expenditure on goods and services consumed in an economy - with perfect enforcement of the tax. The Italian VRR remained stable at 0.38 between 2018 and 2020. The lowest VRR was recorded in the year 2009 at 0.36 and the highest level in 1994 at 0.43.

They notably include the recommended principles and mechanisms to address the challenges for the collection of VAT on cross-border sales of digital products that had been identified in the context of the OECD/G20 Project on Base and Erosion and Profit Shifting (the BEPS Project).
