

## **Logistics Cargo-Handling Services 2023**

## **Key findings**

- The average 2023 STRI in the logistics cargo-handling sector is 0.23 out of a maximum of 1 (most trade restricted), indicating substantial scope for reductions of barriers to services trade. However, individual country scores diverge considerably, ranging between 0.09 and 1.00.
- The best performing countries in the sector are Spain, Japan, and Czechia. Most reforms in 2023 were recorded in Spain, Korea, and China.
- In this sector, barriers related to restrictions on foreign entry are the most prominent and amount to 30% of all restrictions in OECD economies and 48% in non-OECD economies.
- OECD estimates suggest that halving the distance to best practice in this sector is associated with a reduction in the costs of cross-border trade in cargo-handling services between 9% and 23% for the average country included in the STRI database.

Logistics services in the STRI are defined as cargo-handling services (ISIC 5224), storage and warehousing services (including customs warehouse services) (ISIC 5210), freight transport agency services, and customs brokerage services (ISIC 5229). Since the regulatory framework for these four sub-sectors can be different in many countries, separate indices have been developed for each of them.






Figure 1. STRI in logistics cargo-handling services, 2023

The 2023 STRIs in the logistics cargo-handling sector range between 0.09 and 1.00, with a sample average of 0.23 (Figure 1). There are 27 countries below and 23 countries above the average. The best performing countries in the sector are Spain, Japan, and Czechia.

Several countries introduced regulatory changes affecting the STRIs in 2023 and more so since 2014 (Figure 2). In 2023, the STRIs in this sector saw the biggest changes in Viet Nam (8%), Belgium (7%), Portugal (-5%), China (-10%), Korea (-12%), and Spain (-21%). Since 2014, on the one hand, countries that have had the strongest restrictive trends in the logistics cargo-handling sector include Poland (53%), Hungary (51%), and Lithuania (44%). On the other hand, strong liberalisation has taken place in Japan (-26%), Indonesia (-28%), and China (-36%).

The measures in the STRI database are organised under five policy areas (Figure 3). Restrictions on foreign entry include barriers related to establishing and operating companies, such as foreign equity limits or requirements on board of directors and cross-border data flows. Restrictions on the movement of people cover barriers that affect the temporary entry of foreign services providers through quotas, labour market tests, and short durations of stay. Other discriminatory measures include discrimination of foreign services suppliers as far as taxes, subsidies, and public procurement are concerned. Barriers to competition include information on anti-trust policy, government ownership of major firms, and the extent to which government-owned enterprises are exempt from competition laws. Regulatory transparency includes information on consultations and dissemination before laws and regulations enter into force. It also records information on obtaining a license or a visa. In this sector, barriers related to restrictions on foreign entry are the most prominent, amounting to 30% of all restrictions in OECD economies and 48% in non-OECD economies.

In the logistics cargo-handling sector, the Russian Federation is fully closed to foreign firms, with an STRI index of 1.

Table 1 lists the most relevant restrictions identified in each policy area. Under restrictions on foreign entry, common impediments to trade relate to acquisition and use of land and real estate, screening requirements for foreign investments, and residency requirements for board members. 30 out of the 50 countries covered maintain foreign investment screening mechanisms that do not explicitly rule out the consideration of economic motives or interests. A licence or authorisation is required to enter the market in 34 countries.

Restrictions to the movement of people are relatively common across the board. Temporary cross-border movement of contractual services suppliers, intra-corporate transferees, and independent services suppliers is conditional on labour market testing or similar economic considerations in many countries. The initial work or residency permits for contractual services suppliers and independent services suppliers also often have a relatively short duration.

Under other discriminatory measures, barriers related to accessing public procurement markets for foreign tenderers remain the most common challenge. Regarding barriers to competition, in 42 countries, the managing body of a port is not required to separate the accounts of its cargo-handling activities from the accounts of its other activities, and/or cross-subsidisation of these activities is not prohibited, putting other service providers at a competitive disadvantage. Prices or fees are regulated in nine countries.

In the area of regulatory transparency, the most common restrictions relate to the temporary entry/transit of crew. 39 countries do not have visa on arrival or visa exemption for the temporary entry/transit of truck drivers, whereas 16 countries do not offer either option for aircrew. In addition, in 29 countries, individual licences or registration are required for warehousing, freight forwarding, and customs brokerage services, thereby limiting the ability of providers to integrate their activities.

Note: The count for "memo" type of measures, which are not scored in the STRI, indicates the number of positive answers recorded for that measure across the 50 countries covered. The topmost relevant measures are selected on the basis of the following criteria: (1) most restricted horizontal measures (i.e. same answer across sectors), (2) most restricted sector-specific measures, (3) key measures, or (4) memos affecting the score of other measures through hierarchy rules.
