About the OECD Water Governance Initiative (WGI)

The <u>OECD Water Governance Initiative (WGI)</u> is an international multi-stakeholder **network** of 100+ delegates gathering twice a year in a **Policy Forum** to share experience on reforms, projects, lessons and good practices in support of better water governance.

The OECD WGI counts on a diversified geographic, economic and institutional representation at local, national and global levels. Members include representatives from national governments, basin and local authorities (and their networks), regulators (and their networks), donors and international financial institutions, non-governmental organisations (NGOs), international organisations and institutions, service providers (both public and private, and their networks), as well as academics and independent experts. The OECD WGI is hosted by the OECD Centre for Entrepreneurship, SMEs, Regions and Cities (CFE) and has been chaired since 2022 by Barbara Pompili, Special advisor for international affairs at the General Secretariat for Ecological Planning, and former Minister for the Ecological Transition of France.

The WGI, which was created in March 2013, has the following objectives:

- Provide a multi-stakeholder technical platform to share knowledge, experience and best practices on water governance across levels of government.
- Advise governments in taking the needed steps for effective water reforms through peer-to-peer dialogue and stakeholder engagement across public, private and non-profit sectors.
- Provide a **consultation mechanism** to raise the profile of governance in the Global Water Agenda.
- Support the implementation of the <u>OECD Principles on Water Governance</u> in interested member and non-member countries by scaling up best practices and using the indicator framework for self-assessment.
- **Foster continuity on governance** between World Water Fora.
