From Holborn tube station (Central Line):

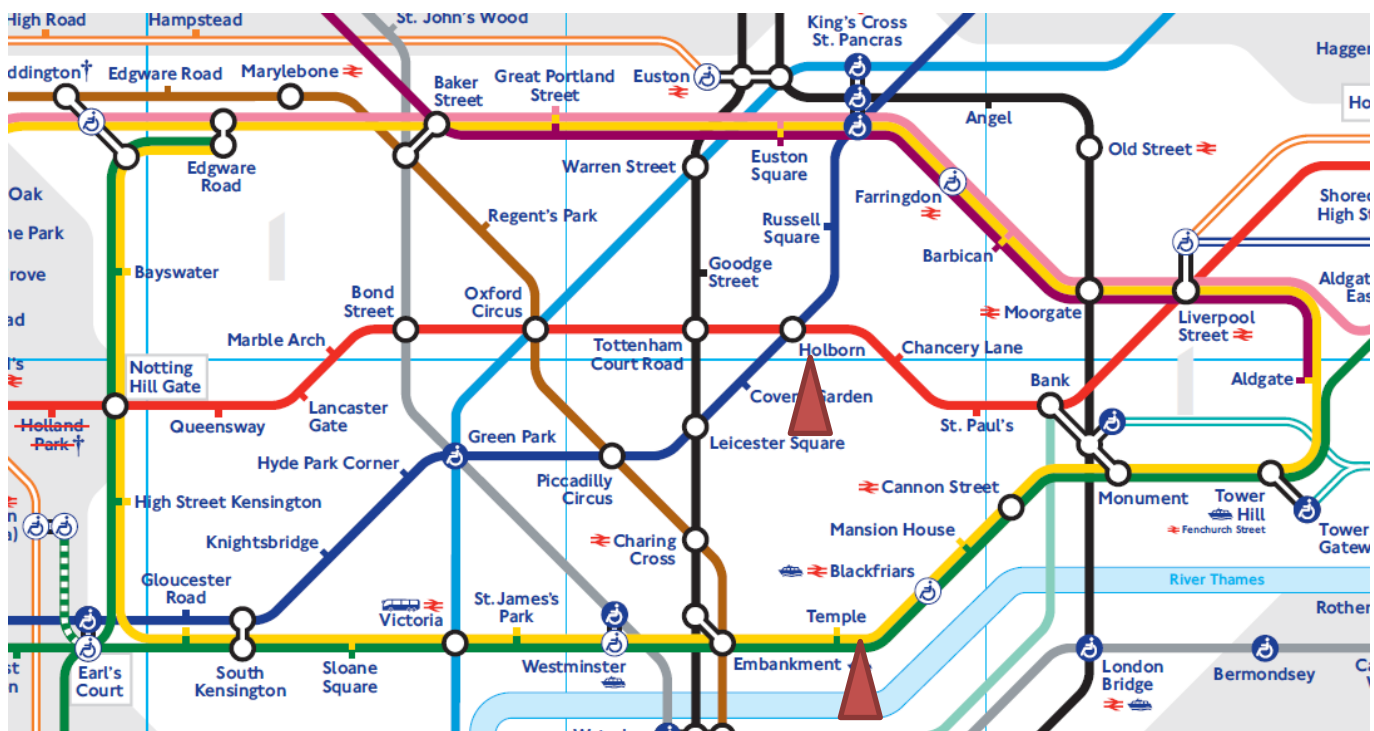
Turn LEFT out of the station onto **Kingsway**

Keep walking for approximately 5 minutes to the end of **Kingsway** and follow **Aldwych** to the left. **Clement House** is on the left immediately after the Post Office on **Aldwych**. The door is clearly marked.

From Temple tube station (District & Circle line):

Turn LEFT out of the station, walk up the steps, then cross over the pelican crossing onto **Arundel Street**.

Walk to the end of Arundel Street, then **cross straight over to the far side of Aldwych**. Follow Aldwych to the left and **Clement House is the second building on the right, just before the Post Office**. The door is clearly marked.



5. VISA ARRANGEMENTS

Participants who require visas to enter the United Kingdom are to make their own arrangements for issuance of entry visa.

6. PARTICIPANTS' REGISTRATION

Registration will be open from 8.30am to 9.30am on Monday 12 December, and from 8:30am on the second day of the meeting.

All participants are required to register at the Registration Desk inside the entrance to Clement House where badges will be issued to participants. Please remember to bring photo identification (e.g., passport, driver's license, etc.) with you. For security reasons,

you must wear your visitor's badge at all times. Those not on the official attendees list will not be admitted.
